

HOUSING CONTRACT TERMS

Cancellation Dates:

Due to scheduling, students are financially committed to summer housing after their housing application and deposit are submitted.

Dates of Operation:

Students move in the Sunday before classes start from Noon - 3:00 p.m. and move out by 3:00 p.m. the last day of finals.

Room/Terms for Payment:

The \$250.00 for each summer housing is due prior to move-in. During summer sessions the entire amount is due up front and there are no installments. Students who are not currently living in the residence hall will also need to pay their \$150.00 deposit prior to move-in. The cost of \$250.00 is for sharing a double-occupancy room for one summer session.

Deposit:

Current Residents: Students deposit will carry over from the Spring Semester.

New Residents: Students will need to pay a \$150.00 deposit along with their application to reserve their room.

Room Rates:

Summer I - Shared room: \$250.00 due prior to move-in

Summer I - Private room: \$500.00 due prior to move-in

Summer II - Shared room: \$250.00 due prior to move-in


Summer II - Private room: \$500.00 due prior to move-in

Important Information About Bacterial Meningitis

This information is being provided to all new college students in the state of Texas. Bacterial Meningitis is a serious, potentially deadly disease that can progress extremely fast – so take utmost caution. It is an inflammation of the membranes that surround the brain and spinal cord. The bacteria that causes meningitis can also infect the blood. This disease strikes about 3,000 Americans each year, including 100-125 on college campuses, leading to 5-15 deaths among college students every year. There is a treatment, but those who survive may develop severe health problems or disabilities.

House Bill 4189 requires that any incoming new student who lives on campus must either receive a vaccination against bacterial meningitis (10 days prior to move-in) or meet certain criteria for declining such a vaccination before they can live on campus. Students that have not submitted this documentation 10-days prior to move-in will forfeit their space as well as their \$150 deposit.
