## Please select one of the following waivers providing appropriate supporting documentation:

- Economic Development (52): Resident rather than non-resident tuition applied to individual and dependents relocating to Texas as part of the program of state economic development. A list of companies participating can be found at <u>www.collegeforalltexans.com</u>.
  Required Documentation: Proof from the student or parent (if dependent) of transfer to Texas by the named company and location; Signed letter of intent to establish residency in Texas.
- Military in Texas (39): Resident rather than non-resident tuition for surviving dependents of members of the Military or Public Health Service that have moved to Texas within 60 days of death of service member.
  Required documentation: Military ID (front and back) or active military duty form or same from Public Health Services; if dependent, IRS statement required to establish dependency. Signed letter of intent to establish residence in Texas.
- Professors/Dependents of Higher Education (42): Resident rather than non-resident tuition applied to individuals and dependents. Required Documentation: letter from human resources of a Texas public institution of higher education verifying at least half-time salaried employment.
- □ Border States (43): Same rate as Texan pays in student's home state. Requires a Financial Aid cumulative 2.0 GPA. Required Documentation: address provided by student.
- <u>Teaching/Research Assistant (49)</u>: Resident rather than non-resident tuition applied to individuals and dependents. Required Documentation: letter from human resources of a Texas public institution of higher education verifying at least half-time employment.
- □ <u>Competitive Academic Scholarship (50)</u>: For recipients of certain scholarships. Resident rather than non-resident tuition. Required Documentation: Notification from Athletic Department or Scholarship Committee.
- □ <u>Out of District Students/Ad Valorem (35)</u>: For out of district students owning property in Cooke County. All or part of out-of-district tuition, renewal award requires Financial Aid cumulative 2.0 GPA. Required Documentation: Cooke County Deed or Tax Statement.
- □ NATO Members and Families (56): Resident rather than non-resident tuition. Required Documentation: Proof of family being stationed in Texas with NATO forces.
- □ **Dual Credit Enrollment Jr College (36):** Waiver of some tuition and fees as agreed with ISD. Required Documentation: Letter from High School Counselor.
- Military Intention to stay in Texas (41): Resident rather than non-resident tuition for individuals and dependents. Required documentation: Military ID (front and back) or active military duty form or same from Public Health Services; if dependent, IRS statement to establish dependency; Signed letter of intent to establish residence in Texas.
- Good Neighbor Scholarship (16): Competitive award for waiver of tuition for one year, renewal award requires Financial Aid and 2.0 GPA. Required Documentation: Notification from Financial Aid.
